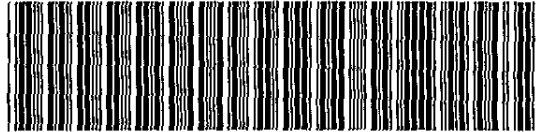

ARTICLE I.


NAME

Except as specifically amended hereby, the Articles of Incorporation shall remain in full force and effect.


