Pursuant to my telephone conversation on October 9, 2003 with Justin of your department, I enclose the Application for Reinstatement for the referenced Corporation.

The Uniform Business Report was mailed in a timely manner. Together with the Report, the \$150.00 annual renewal fee was paid. The check was cashed by the Department of State of March 5, 2003.

Justin stated that non payment was not the issue, but rather that the Registered Agent was changed, and the Registered Agent Signature block was erroneously left blank.
