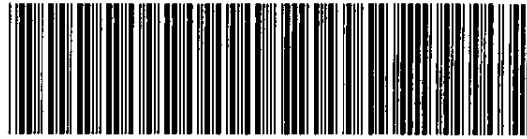

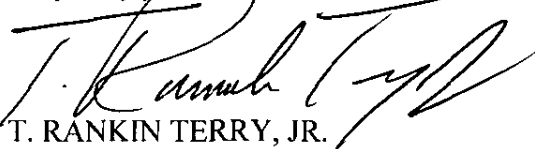

AMENDMENT TO
ARTICLES OF INCORPORATION
OF
J.D.C.I. ENTERPRISES, INC.

The undersigned sole shareholder and director hereby amends the Articles of Incorporation filed with the Florida Secretary of State on April 12, 1982, as follows, except as stated in Article VI below, effective when filed with the Florida Secretary of State:

ARTICLE I – NAME

The name of the Corporation shall be **JDCI ENTERPRISES, INC.** Removing the periods behind the first four (4) letters.

ARTICLE VI – DIRECTORS

The Corporation shall have at least one (1) director. The number of directors may be changed by the by-laws upon a vote of the majority of stock ownership.

The current director is JOSEPH K. ISLEY, III.

A director shall serve until their successor(s) are elected or appointed and have qualified.

This Amendment was effective August 6, 1998.

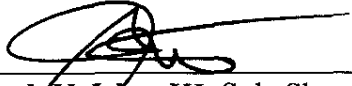
ARTICLE XI – BY-LAWS

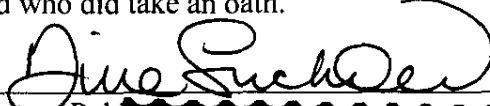

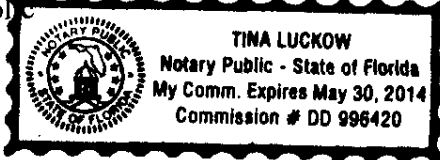
