ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Section 607, Florida Statutes, CHESTER A. AIKENS, D.D.S, P.A., a Florida professional association (the "Corporation"), adopts the following Articles of Amendment to the Articles of Incorporation:

1. The name of the Corporation is CHESTER A. AIKENS, D.D.S, P.A.
2. The Articles of Incorporation were filed on April 27, 1982 and assigned document number F77975.
3. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"ARTICLE I. NAME
