**ARTICLES OF AMENDMENT
OF THE ARTICLES OF INCORPORATION OF
ROBEY-BARBER INSURANCE SERVICES CORPORATION**

Pursuant to Section 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of Robey-Barber Insurance Services Corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Robey-Barber Insurance Services Corporation.


SECOND: Article I of the Articles of Incorporation shall be amended in its entirety to read as follows:

"The name of the Corporation shall be McNulty-Barber Marketing, Inc."

THIRD: The foregoing amendment was adopted by written consent of the sole shareholder and director of the Corporation, constituting a sufficient number of votes for the amendment to be approved in accordance with Sections 607.0821 and 607.0704 of the Florida Statutes, on November 29, 1999.
