**ARTICLES OF DISSOLUTION AND
CONSENT TO USE OF NAME
JEFFREY R. LASH, D.M.D., P.A.**

The undersigned, being the President of JEFFREY R. LASH, D.M.D., P.A., does hereby adopt the following Articles of Dissolution pursuant to Florida Statutes §607.1403.

1. NAME OF CORPORATION: The name of the corporation being dissolved is JEFFREY R. LASH, D.M.D., P.A. (the "Corporation").

2. DATE OF INCORPORATION: The original Articles of Incorporation of the Corporation were filed on 6/4/82.

3. DATE DISSOLUTION WAS AUTHORIZED: By unanimous consent of all of the Shareholders, the Dissolution of the Corporation was authorized on 11/26/96.

4. SUFFICIENT AUTHORIZATION: The number of votes cast by the shareholders in favor of dissolution was sufficient.
