**RESTATED ARTICLES OF INCORPORATION  
OF  
SOUTHSIDE PLUMBING INC**

Pursuant to Section 607.1007, Florida Statutes, the corporation's Board of Directors restates its Articles of Incorporation as follows:

**Article I**

The name of the corporation is Southside Plumbing Inc.

**Article II**

The street address of the corporation's principal office is 2671 Rochelle Lane, DeLand, Florida; the mailing address of the corporation is Post office Box 157, Lake Helen, Florida 32744.

**Article III**

The primary purpose of this corporation shall be plumbing contracting and to engage in any other activity or business permitted under the Laws of the United States and the Laws of the State of Florida.

**Article IV**

This corporation shall have a perpetual existence unless sooner dissolved according to law.

**Article V**

The aggregate number of shares that the corporation shall have the authority to issue is: five hundred (500) shares par value, in capital stock, all of one class, with a par value of one Dollar (\$1.00) per share.

## **Article VI**

The amount of capital with which this corporation shall commence business shall be in excess of five hundred dollars (\$500.00).

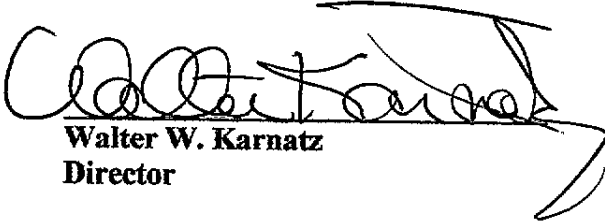
## **Article VII**

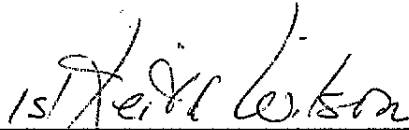
