DEAR SIR OR MADAM:

ATTACHED PLEASE FIND FORM #203 REINSTATEMENT (CORP). IN MARCH OF 1999 MR GORDON MARSH, SIR, WHO IS THE PRESIDENT OF WALL STREET PROPERTIES, UNDER WENT A TRIPLE BY-PASS OPERATION. AFTER THE OPERATION MR MARSH SUFFERED A STROKE AND HIS DAUGHTER, NANCY, WAS MADE HIS GUARDIAN. NANCY HAD ALL THE MAIL FOR THE CORPORATION FORWARDED TO HER HOME ADDRESS IN JUPITER. NANCY KNEW NOTHING ABOUT RUNNING A BUSINESS OR THE FORMS THAT HAD TO BE FILED. I WAS GIVEN THE RIGHT TO SIGN CONTRACTS, PAY BILLS, DO TAX RETURNS AND HANDLE THE DAY TO DAY AFFAIRS WITHOUT ANY LIABILITY TO ME.

DURING THE PROCESS OF UPDATING THE ANNUAL RETURNS I CALLED YOUR OFFICE TO SEE WHAT HAPPENED TO THE RENEWAL FOR 2000. IT WAS AT THAT TIME I FOUND OUT THE RENEWALS HAD GONE TO NANCY AND THE CORPORATION HAD DEFAULTED AND IT HAD TO BE REINSTATED.

MR MARSH IS GETTING PROGRESSIVELY BETTER AND IS IN ASSISTED LIVING FACILITY. THE MONEY HE GETS FROM RENT TAKES CARE OF HIM. HE HAS NOTHING TO SPARE. I AM ASKING THAT DUE TO THE EXTENDUATING CIRCUMSTANCES YOU ONLY CHARGE HIM THE NORMAL ANNUAL FEE FOR 1999 AND 2000 FOR THE REINSTATEMENT INSTEAD OF THE \$900.00 QUOTED TO ME ON THE PHONE.


