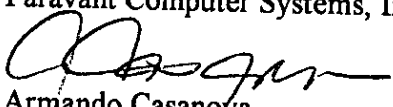
Enclosed please find Form CR2E081 Corporation Reinstatement, duly completed for Paravant Inc., which had failed to complete the Annual Corporation Report for 2002. Over the course of the past four years, restructuring of the affiliate/controlled group under the Company's name has resulted in the renaming of the original Paravant, Inc. operation, (now Paravant Computer Systems, Inc., filed Jan 30, 2002 under Document Number P98000008088), the conversion of Paravant, Inc. into a holding company for a group of affiliates and its relocation to Morristown, NJ. Likewise, all tax preparation services, which included the Annual Corporation Report, were moved last year from the Orlando office of KPMG LLC to its Short Hills, NJ office, a process during which that report was omitted for 2002.

As the new Director of Finance for Paravant Computer Systems, Inc., I have determined through my review of the corporate status of the companies that Paravant Inc. has been administratively dissolved by your office on October 4, thus this application.

This application includes our check no. 1429 for \$150.00, following the advice of your Staff. Given the intense transitional activity in which the Company has been involved in recent months, which resulted in a good faith oversight of the filing, we respectfully request the abatement of the \$600.00 penalty associated with the untimely filing, which will not reoccur in the future.

Anticipating your favorable response to this request, we remain.
