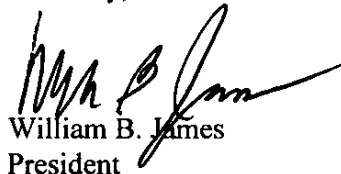
I have just received a postcard in regards to the dissolve/revoke issue of our business. Please note that this is the first indication I have had that our Annual Report had not been filed.
