ARTICLES OF MERGER

These Articles of Merger were prepared in accordance with Section 607.1105, Florida Statutes to be filed in the office of the Secretary of the State of Florida in accordance with law. As provided by law, the parties to this merger submit the following:

1. The two corporation which are a party to this merger are both Florida Corporations, namely MILTON TERMINAL, INC., charter number H18561, and MAGNUM INVESTMENTS OF TALLAHASSEE, INC., charter number F89150.
2. T. L. McKenzie is the sole stockholder and only director of each corporation which is a party to this merger. The plan of merger is for MILTON TERMINAL, INC. to be merged into MAGNUM INVESTMENTS OF TALLAHASSEE, INC. with MAGNUM INVESTMENTS OF TALLAHASSEE, INC. to be the surviving corporation. T. L. McKenzie will tender his stock in MILTON TERMINAL, INC. for cancellation and immediately after consummation of the plan of merger he will continue as sole stockholder of the surviving corporation, MAGNUM INVESTMENTS OF TALLAHASSEE, INC.
3. The effective date of the merger shall be January 1, 1997.
4. The date of adoption of the plan of merger by the stockholders and directors of both corporations was December 23, 1996.
