ARTICLES OF AMENDMENT OF DAMAR MANUFACTURING, INC.

These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of DAMAR MANUFACTURING, INC. and in connection therewith, the undersigned officer, acting upon authority of the Board of Directors of DAMAR MANUFACTURING, INC., and upon authority of all of the shareholders of this Corporation, hereby sets forth as follows:

- The name of this Corporation is DAMAR MANUFACTURING, INC.
- 2. The Articles of Incorporation of DAMAR MANUFACTURING, INC. have been amended by deleting Article IV in its entirety and by substituting in lieu thereof the following Article IV:

Without action by the stockholders, any or all of the said shares of stock may be issued by the Corporation from time to time for such consideration, as may be fixed from time to time by the Board of Directors (hercinafter called the Board) of the Corporation, and any and all such shares to be issued, the full consideration for which has been paid or delivered, shall be deemed full paid stock and not liable to any further call or assessment thereon, and the holder of such shares shall not be liable for any further payment thereof.

No holder of shares of common stock shall be entitled as such as a matter of right to subscribe for or purchase any part of any new or additional issue of
