Dear Ms. Bartlett:

I am writing this letter on behalf of Travelers in response to the Notice of Administrative Dissolution that it recently received from your office. Travelers wishes to be reinstated in the State of Florida as quickly as possible and also wishes to clarify the circumstances surrounding the submission and subsequent rejection of its 1996 Annual Report (the "1996 Annual Report"). To this end, we have completed the Application for Reinstatement, have enclosed a \$200 check and have summarized below information of which we feel you should be aware.

- Travelers filed its 1996 Annual Report on a timely basis on April 22, 1996 and submitted a check in the amount of \$200.00 along with it. I have attached a photocopy of the report and check for your reference. To date, the check has not been cashed.
- Upon my inquiry on October 14, 1996, your office informed me that the 1996 Annual Report was returned by mail to Travelers around May 15, 1996 along with the \$200 check and a letter explaining why the report was rejected. Travelers has no record of receipt of this package and as a result, was not aware that its 1996 Annual Report had been rejected until it received your Notice of Administrative Dissolution (the "Dissolution Notice") earlier this month. Please note that our state was incorrectly listed as NE (instead of NY) on the envelope in which the Dissolution Notice was sent and the material was not sent to attention of any particular person at Travelers. (A copy of the envelope is attached for your reference.) The manner in which the envelope was addressed (wrong state and no person's name) may have been the reason we did not receive the material you returned to us in May.
- Upon my inquiry on October 14, 1996, your office also informed me that Travelers' filing was rejected because it failed to list street addresses of each of its officers on its 1996 Annual Report. Since street addresses were listed for each officer, I am confused by this comment. As a result, we remain uncertain of the reason for which our report was rejected.


