FIRST: That SECTION 1.1 of the Declaration of Trust of the REIT is hereby amended by deleting therefrom the name "Mark Centers Trust" and by substituting in lieu thereof the name "Acadia Realty Trust." 82268098

SECOND: That SECTION 6.1 of the Declaration of Trust of the REIT is hereby amended by deleting from the second sentence thereof the number of "50,000,000" and by substituting in lieu thereof the number "100,000,000."

THIRD: This Amendment to the REIT's Declaration of Trust was duly approved by the affirmative vote of the holders of not less than an a majority of the shares issued by the REIT and then outstanding on July 8, 1998.
