Dear Sir or Madam:

We attach two (2) annual report forms for IMT Corporation (Michigan) and Atlas Machinery AG USA Inc. These were received here on June 30th, 1998. We did not receive any prior reports this year for either company.

Since January 31, 1997, we have had no employees at IMT Corporation, and Atlas Machinery never started operating (no sales, no employees) since its inception in 1996. Atlas was founded in order to do export business of machines mainly to Spain, Italy and Holland, but one of the main intended partners changed his mind and the business never materialized.

In 1996 and 1997 we unfortunately had considerable losses because the automotive industry changed from purchasing polyurethane machines that we sell (since 1983), to buying thermoplastic machines (PPO and SMC type). As a consequence, we laid off employees as of January 31, 1997.

We see early signs of recuperation of our polyurethane technology, probably resulting in a first sale to supplier to a German auto company in South Carolina during July/August of 1998. This would be our first new machine sale since January of 1997. The machine to be supplied is built in Grand Rapids, Michigan.

Due to no action on our behalf, we are in a situation where we have this potential liability for filing fees of 2 x \$550.00, totaling \$1,100.00 which we are unable to pay, as we have no funds. (The same type of filing fee at the State of Michigan is \$15.00 per year!)

Atlas Machinery, if we have no prospect of business in the next 3-4 months could be dissolved; Atlas has no assets or business.

Please let us know if both fees are necessary at \$550 each, since Atlas has had zero business and no assets. Can we simply pay \$150.00 for IMT Corporation filing fee, since we only received the filing document on June 30th of this year? Must we pay also the \$150.00 for Atlas Machinery?

We await your kind reply, thank you.
