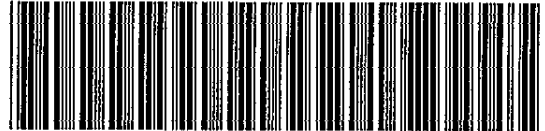

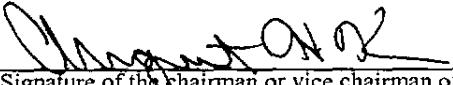

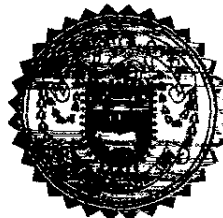

Marriott Senior Living Services, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

**DOES HEREBY CERTIFY:**

**FIRST:** That the sole Director of said corporation, by the written consent of such sole Director, adopted the following resolutions:

**RESOLVED**, that, subject to the approval and adoption by the corporation's sole stockholder, the Restated Certificate of Incorporation of Marriott Senior Living Services, Inc. be amended by changing subsection (a) of the First Article thereof so that, as amended, said subsection of such Article shall be and read as follows:


1. (a) The present name of the corporation (hereinafter called the "corporation") is Sunrise Senior Living Services, Inc.

**SECOND:** That in lieu of a meeting and vote of stockholders, the sole stockholder of the corporation has executed a written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

**THIRD:** That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware.

**FOURTH:** That this Certificate of Amendment of the Certificate of Incorporation shall be effective upon filing this Amendment.
