Certificate of Amendment of the Certificate of Incorporation

Of

Surgical Aid to Children of the World Under Station So3 of the host-for Refit Corporation Line

FIRST: The name of the Corporation is Surgical Aid to Children of the World.

SECOND: The certificate of incorporation of Surgical Aid to Children of the World was filed on May 4, 1981, as a Not-for-Profit corporation, as defined in subparagraph (a) (5) of Section 102 of the Not-for-Profit Corporation Law.

THIRD: The Corporation is a Type B Corporation as defined in Section 201 of the Not-for-Profit Corporation Law and is not for pecuniary profit or financial gain. The purposes of the Corporation are (A) to assist others in the development of programs supporting the improved delivery of pediatric surgery and child care and development in various countries of the world, provided that no such program shall be offered in New York State; (b) to solicit, receive and administer a fund or funds to be applied exclusively for the charitable, scientific and education purposes the Corporation, particularly, making contributions to provide for the travel expenses and maintenance of physicians and other persons participating in such programs; and (c) to take any and all actions which are incidental to and not inconsistent with the foregoing purposes of the Corporation and which are lawful for not-for-profit corporations.

FOURTH: Paragraph FIRST of this Certificate of Incorporation in hereby amended in its entirety to read as follows:

FIRST: The name of the Corporation is Children-Surgical Aid International. Paragraph EIGHT of the Certificate of Incorporation is hereby amended in its entirety to read as follows:

EIGHT: The post office address to which the Secretary of State shall mail a copy of any notice is 114 Cedar Avenue, Hewlett Bay **Park**, New York 11557.

FIFTH: This certificate of amendment of the certificate of incorporation was authorized by the unanimous written consent of the Board of Directors of the Corporation.

SIXTH: The Corporation hereby designated the secretary of state as agent of the Corporation upon whom process may be served. The post office address to which the Secretary of State shall mail a copy of any notice is 114 Cedar Avenue, Hewlett Bay Park, New York 11557.
