On February 17, 1996, I was involved in a rear end collision in which my head was thrown back through the back window of my 1981 Chevrolet El Camino. The window was smashed out and the vehicle was totaled.

As a result of the various lacerations, neck and back injuries, I am unable to work as I once did, since I work alone.

In the following years my bills kept adding up, especially my child support payments of \$725.00 per

month. Having been ordered to court several times as of December 4, 2000, I was roughly \$20,050.00 in arrears. After securing legal counsel and incurring thousands of dollars in legal fees, I was able to have my support payment reduced to \$325.00 a month, which is quite a relief, but I still owe the \$20,050.00 in arrears, which I am ordered to pay every month until paid off.

Having all these financial problems, I was unable to pay my 2002 Uniform Business Report. I have been in business since 1982 and paid my report fees orderly and on time every year, remembering when it was only \$5.00, a far cry from \$150.00 now.

I'm asking the Division of Corporations to consider my financial situation, as I am trying as hard as I possibly can to make ends meet and stay in business, and waive the additional penalties and reinstatement fees. PLEASE! Thank you.
