

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CENTRAL BEER IMPORT & EXPORT, INC.

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of CENTRAL BEER IMPORT & EXPORT, INC., a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is CENTRAL BEER IMPORT & EXPORT, INC.
