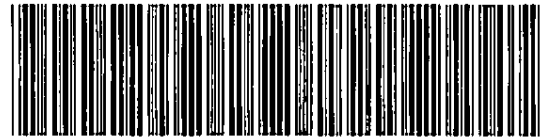

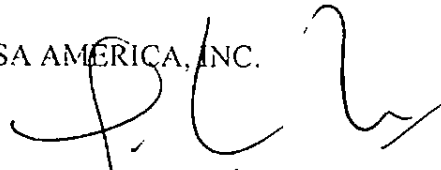
RESOLVED, that in the judgment of the Board of Directors, it is deemed advisable to amend Article FIRST of the Certificate of Incorporation as follows:
