Dear Agent:

I submit the following in response to your correspondence to the above company and my telephone conversations with other State Department representatives.

DFS filed its 1999 Annual Report on or about April 22, 1999. The required payment of \$150 was remitted with the return. The original return signified a correction to the current registered agent; however, because there was no signature of the new registered agent, the Annual Report was returned by the Department of State as incomplete along with correspondence dated May 25, 1999. DFS returned the signed report to the Department of State eliminating the correction to the current registered agent on or about June 3, 1999. The company received notification of Administrative Dissolution on or about October 15, 1999.

The original return was filed with a correction to the current registered agent that had been preprinted on the form. This was done because the forms to change the registered agent had recently been filed with the State of Florida. After the report was returned, I spoke with a Department Agent and was instructed to resubmit the form without the change to the current registered agent since that change was being handled through different channels.

As you will note, the Application For Reinstatement does list the current registered agent as the agent that was corrected on the original report filed April 22, 1999. The report was returned signed by the then current registered agent in early June. It was not until October, when the revocation notice was received, that we were made aware that the problem had not been corrected. Upon speaking to another Department Agent, it was determined that the corrected form had never been received by the State or was lost after being received. I was instructed to return the Application For Reinstatement along with an explanation in order to have the corporation reinstated without incurring the \$600 Reinstatement Fee.

Based on the good faith effort made by DFS as detailed above, I request that DFS be reinstated and that the reinstatement fee be waived.
