Permissibility of Doing Business in Ohio Under Name that Includes "Trust"

Dear Ms. Solganik:

This is in connection with a filing with the Secretary of State of Ohio that involves doing business in Ohio using names that include the word "trust", specifically:

> AmTrust Investment Services, Inc. AmTrust Insurance Agency, Inc. AmTrusi Title Agency, Inc. AmTrust Real Estate Investments, Inc.

Division (B)(1) of §1101.15 of the Ohio Revised Code, with specific exceptions, prohibits persons other than bona fide trusts and persons authorized to engage in trust business doing business in Ohio under a designation or name that includes "trust".

We have verified that Ohio Savings Bank is a savings bank doing business under authority granted by the Office of Thrift Supervision, but is not currenly authorized to engage in trust business. The bank has recently received approval from the OTS to change its corporate title from Ohio Savings Bank to AmTrust Bank. The OTS does not require a bank to be authorized to engage in trust business to use the word "trust" in its name. Because the OTS has approved the new name of AmTrust Bank, the Division has no objection to the affiliates of AmTrust Bank using the proposed names listed above.

This is not an opinion on the availability of the names "AmTrust Investment Services, Inc.; AmTrust Insurance Agency, Inc.; AmTrust Title Agency, Inc.; or AmTrust Real Estate Investments, Inc". This is also not an authorization to use the names, and this does not protect the user against any lawful claims of persons or entities having superior rights in the same or a similar names.
