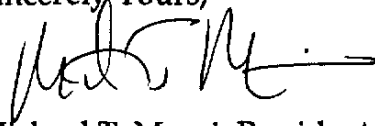
Gentlemen:

In response to your notice regarding the above, it is not the intention of the corporation to willfully neglect the law. However, it is my understanding that mail is not always received at the corporate address. This address is in my name, Michael T.
