1. *Staphylococcus aureus* (ATCC 12228) was grown in tryptic soy broth (TSB) (Difco) supplemented with 0.5% yeast extract (Difco) and 0.5% glucose (Difco) at 37°C. Cells were harvested at mid-log phase (OD₆₀₀ = 0.5) and washed with phosphate buffered saline (PBS) (pH 7.4) containing 0.1% bovine serum albumin (BSA) (Sigma). Cells were then resuspended in PBS containing 0.1% BSA and 0.1% penicillin (100 U/ml) (Sigma). Cells were then lysed by sonication (10 s, 300 W) and centrifuged at 14,000g for 10 min. The supernatant was then dialyzed into PBS containing 0.1% BSA and 0.1% penicillin (100 U/ml) (Sigma). The protein concentration was determined by the method of Bradford (1976) using a Bio-Rad protein assay reagent (Bio-Rad). The protein was then stored at -20°C.

5. *Chlorophyll a* and *Chlorophyll b* content of the leaves was determined by the method of Arnon and Whistler (1940).

The Board concluded that the information contained within the previously identified, highlighted and discussed aspects of the correspondence, taken as a whole, does not constitute evidence of fraud. The Board also noted that the information disclosed in the correspondence of the governmental group reported to, and accepted by, the Legislature, does have the same impact effect as if made under oath. That the information contained in the correspondence of the group of business companies would be considered the report as prepared by a private law, business entity, and that the various sources of the law, or the law of business, are not subject to criminal sanctions.
