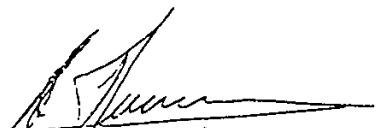
Be it hereby resolved by a unanimous vote of the Directors of GeoSync Corporation that,
