11. *Explain the difference between the two types of sampling. Give an example of each type of sampling. The difference between the two types of sampling is that in simple random sampling, every member of the population has an equal chance of being selected. In systematic sampling, members of the population are selected at regular intervals. For example, if a researcher wants to select 100 members from a population of 1000, they could use simple random sampling to select 100 members, or they could use systematic sampling to select every 10th member of the population.*
