

PLAN OF MERGER

- "I. Thomson Learning Inc., which is a business corporation of the State of Delaware and is the parent corporation and the owner of all of the outstanding shares of Thomson Learning Licensing Corp., which is a business corporation of the State of Florida and the subsidiary corporation, hereby merges Thomson Learning Licensing Corp. into Thomson Learning Inc. pursuant to the provisions of the Florida Business Corporation Act and pursuant to the provisions of the laws of the jurisdiction of organization of Thomson Learning Inc.
