The following is a list of events leading up to today's date of Janyary 30, 1998:

<u>4/22/97</u> Call to the Florida Dept. of State inquiring how I can obtain the 1997 Annual Report. I was instructed by Melissa to just use the 1996 Report and white out 1996 and change it to 1997.

4/23/97 Call to the Florida Dept. of State, this time inquiring about changing the Registered Agent. I was instructed by Sharon that the Registered Agent must have a Florida address, but that an address change for mailing can be made by crossing out the current mailing address on the Annual Report, and type the new mailing address in block 2a of the Report and it will be changed. The filing Fee was \$165.00. I made the changes on the form as instructed and mailed with a check for \$165.00.

5/19/97 Call to the Florida Department of State to checking on the status of the 1997 Annual Report and was told by Lee that the Report was mailed back to the Registered Agent signature. He referred me to the reinstatement department at 904-487-6059

Call to the reinstatement department and spoke with Amy. She told me that their records indicated that the Report and check was sent back to the Registered Agent for signature, but could not tell me what the mailing address was.

It turns out that they mailed it back to the Registered Agent, Thomas J. Hodge, in Florida, ignoring the address change that was requested. A letter of explanation was sent along with the Report dated May 3, 1997. The Registered Agent held on to this paperwork and did nothing with it.

<u>1/27/98</u> Call to the Florida Dep. of State inquiring the status of the corporation and was told by Doug that it was dissolved 9/26/97 and that I needed to talk to the reinstatement department. I called them and spoke with Leslie. I was instructed by Leslie that the following would be do in order to reinstate:

\$ 165 for 1997

\$150 for 1998

\$ 900 for reinstate fee

Leslie said that if a letter of explanation was sent with the Report, and if fault was found to be on their end, that the reinstatement fee of \$ 900 would most likely be waived.

1/30/98 Was told by Andy in the reinstatement department that the signature of the Registered Agent would not be required if the reinstatement fee was waived. It would be treated as standard renewal report.
