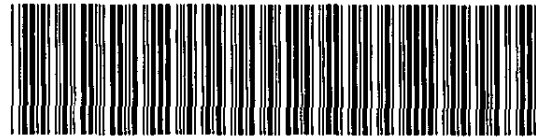

Pursuant to KRS 271B.10-060 of the Commonwealth of Kentucky, the undersigned corporation hereby adopts the following Articles of Amendment.

I.

The name of the corporation is Presnell Associates, Inc.
