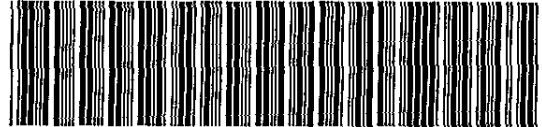

Pursuant to Florida Statutes Section 607.1006, the Articles of Incorporation of the above named Corporation are hereby amended to read as follows:

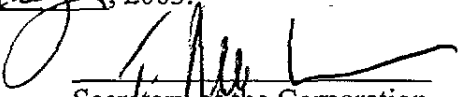
1. Article 1 is hereby amended to read as follows:

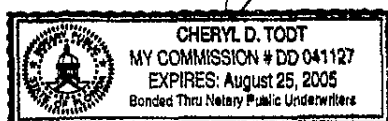
