ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WAKULLA BANCORP

Prior to the effectiveness of this Amendment, the only class of issued and outstanding capital stock of the Corporation was common stock. On November 17, 2009, the Corporation received written consents authorizing the Amendment from the holders of a majority of the outstanding shares of common stock of the Corporation given in accordance with Section 607.0704 of the Act, the Articles of Incorporation, as amended, and Bylaws, as amended, of the Corporation.
