Bernard H. Bard, being duly sworn, deposes and says:

- 1. I am the Executive Vice President and Chief Financial Officer of RT Industries, Inc. ("RT"), a Delaware corporation, having its principal place of business at 7280 West Palmetto Park Road, Boca Raton, Florida.
- 2. RT Friction, Inc. ("Friction"), a Missouri Corporation, is a wholly-owned subsidiary of RT.
- 3. In connection with a certain loan agreement entered into between RT and RT's secured lender, Friction was required to qualify to do business in the State of Florida.
- 4. Consequently, an application (the "Application") for authority to transact business was submitted for filing on behalf of Friction with the Florida Department of State.
- 5. As a wholly-owned subsidiary of RT, Friction's books of account are maintained by RT's administrative staff in the State of Florida. In addition, Friction's bank accounts are maintained in the State of Florida and the meetings of Friction's Board of Directors are held in RT's Florida offices (the same individuals constitute the Board of Directors of both Friction and RT, all of whom reside in Florida).

The foregoing are the only activities carried out by Friction in the State of Florida.

6. The Application indicated Friction conducted business in Florida since October 1, 1992 (the date Friction commenced its business operations) under the mistaken belief that the activities referred to in Item 5 above constituted doing business in Florida.

- 7. Section 607.1501(2) of the Florida Statutes (1993) provides that the activities referred to in Item 5 above do not constitute transacting business in the State of Florida within the meaning of Section 607.1501(1).
- 8. Friction has not transacted business in the State of Florida within the meaning of Section 607.1501(1) prior to the Application filing year and the information contained in the Application that Friction first transacted business in Florida on October 1, 1992 is incorrect:
