

Pursuant to your letter of 06 December 1994 regarding the current Wage Determination incorporated in the above referenced contract for labor catagory, Guard, Unarmed, I am providing this reply as requested.

IAW the Fair Labor Standards Act as amended May 1989, VERTECH, Inc. has elected to utilize the Wage Determination 94-2573 (rev 1) dated 11 July 1994 as the basis for personnel compensation. In deference to our employees, I have contacted the U.S. Department of Labor Wage and Hour Division, Washington, D.C. for guidance and support in application of a revised Wage Determination for incoproration into this contract refelecting not less than the previous wage rate.

In the event a negotiation in decreased invoice is required prior to incorporation of a revised Wage Determination, I will provide you will applicable calculations based upon our intrinsic costs.
