Joseph A. DiGiacomo, being duly sworn, deposes and says:

- I am the Treasurer of Grumman Data Systems Corporation (GDSC).
- I make this affidavit for the purpose of responding to the inquiry raised by the Division of Corporations, Secretary of State, in response to the application of GDSC to register to do business in the State of Florida.
  - GDSC maintains no office in Florida.
- Thirty-seven GDSC employees are temporarily assigned to the Melbourne, Florida facility of GDSC's affiliate, Grumman Aerospace Corporation (GAC), which is registered to do business in Florida.
- While these employees technically remain GDSC employees, their day to day responsibilities are in GAC's facilities, supervised by GAC's management.
- These employees are the only connection GDSC is aware it has with the State of Florida.
- 7. GDSC does not believe that this creates such a nexus that requires GDSC to register, pursuant to Florida law. such, up to this date, GDSC has not registered with the Division of Corporations, Florida Secretary of State.
