

- 1. The present name of the corporation is Mountaineer Long Distance, Inc. (the "Corporation").
- 2. The name under which the Corporation was originally organized was Show-Me Long Distance, Inc.
- 3. The following amendment to the Corporation's Articles of Incorporation was adopted by the shareholders of the Corporation as of January 23, 1995:
