The purpose of this letter is to confirm that the Certificate of withdrawal for IDL Mortgage Corporation with a FI document number of F95000000298 was not authorized by anyone in this corporation. We have a Certificate of authorization to do business in FL dated May 21, 1997.

The Certificate of Withdrawal was most likely intended for the previous IDL Mortgage Corporation that had a Florida document number P00403. I was the president of that corporation also but it was part of a corporate merger and purchased by Bank of America out of California in July of 1994. Bank of America closed down all offices of IDL Mortgage and when the name became available in Florida and Wisconsin, we changed the name of our corporation to IDL Mortgage Corporation. The new IDL has nothing to do with the old IDL.

I can certainly understand the confusion, but this letter will confirm that IDL Mortgage Corporation with FI document Number F95000000298 has ~~not~~ requested to have its corporation withdrawn. We request that the Certificate of Withdrawal issued by mistake be withdrawn.
