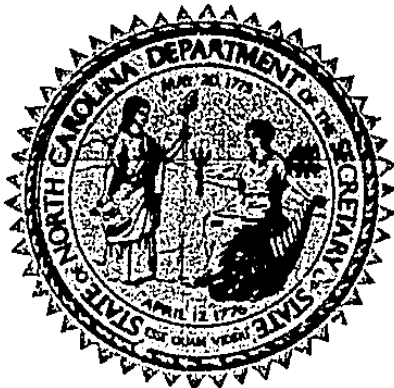
CERTIFICATE OF EXISTENCE
