Dear Ms. Lott:

We are responding to your correspondence dated January 21, 1994 and January 24, 1994 for the above-named clients. We have enclosed copies of the correspondence for your reference.

The Department of State contacted these companies inquiring whether they were transacting business in Florida as defined in Florida Statute Sec. 607.1501, Authority of Foreign Corporation to Transact Business Required. If the companies were transacting business, then they were requested to file the appropriate forms to register and pay the applicable fees. The Department of State contacted the companies to make the inquiry based upon the fact the companies filed corporation tax returns in Florida.

The companies responded to the inquiry and indicated that they were transacting business for a period of years and filed registration statements and paid \$70.00 each for the current year. The Department of State responded by assessing additional charges to Glacial Sand & Gravel Co. in the amount of \$3,031.25 and \$5,631.25 to Allegheny Mineral Corporation.

We have reviewed the facts relative to both cases and have determined that neither corporation is transacting business without authority in Florida; therefore, neither company should have filed for a Certificate of Authority. We request the Department of State return both checks for the current applications and consider the applications abandoned.

The companies are partners in two citrus grove partnerships and receive federal income tax forms Schedule K-1, Partner's Share of Income, Credits, Deduction, etc., reporting their share of income and expenses from the partnership activities. This is their only interest in Florida and this income and expense is reported in the Florida corporation tax returns which are filed.

Based upon our reading of the statute, owning a partnership interest is not, by itself, conclusive of transacting business and requiring the filing for a Certificate of Authority. Neither Glacial Sand & Gravel Co. nor Allegheny Mineral Corporation manage or exercises the powers and duties of a general partner with respect to the citrus grove operations. These responsibilities are handled by the Florida based partner through a management company. Glacial Sand & Gravel Co. and Allegheny Mineral Corporation are merely passive investors in the partnerships.

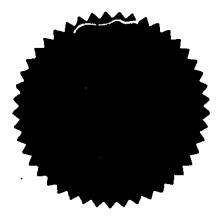
