#### ARTICLES OF INCORPORATION

ARTICLE ONE

Corporations Section

The name of the corporation is The Association of Messianic Believers.

ARTICLE TWO

The corporation is a non-profit corporation.

ARTICLE THREE

The period of its duration is perpetual.

#### ARTICLE FOUR

The purpose or purposes for which the corporation is organized are:

- 1. To provide an expression for the Messianic Jewish community for the purpose of public relations, defense/apologetics and coordination. In addition, this organization shall work in concert with the Union of Messianic Jewish Congregation (U. M. J. C.)
- 2. To form an umbrella organization both Jewish and Gentile believers with a Messianic vision.
- 3. To unite in an international cooperative fellowship community. Messianic Jews and Gentiles.
- 4. To advance the spiritual development, general welfare and Messianic Jewish knowledge of Messianic believers.
- 5. To extend practical aid to Messianic believers in need.
- 6. To further the education of Messianic believers preparing for the ministry.
- 7. To discover and meet the needs of the Messianic Jewish community.
- 8. To assist in conflict resolution among individuals.
- 9. To provide a united witness for the Messiah to the Jewish community, of which we are a part: to encourage Messianic outreach among the Jewish people internationally; to prepare and publish literature setting forth the message of the Messiah for the Jewish people.
- 10. To bring about better understanding of the Jewish people to the Church and to combat anti-Semitism.
- 11. To communicate the nature and aims of Messianic Judaism to our society.
- 12. To demonstrate our solidarity with the rest of the Jewish community.
- 13. To demonstrate our solidarity with the rest of the Body of Messiah.

  14. To encourage, establish, and maintain local branches.
