Statement of correction of information provided by Advanced Aviator, S.A. when they submitted the "APPLICATION BY FOREIGN CORPORATION FOR AUTHORIZATION TO TRANSACT BUBINESS IN FLORIDA FORM".

The information provided on line 6 of the original form, which showed a date of January 6th, 1984 as the original date in which the aforementioned company started to transact business in the State of Florida is incorrect due to a clerical error. Advanced Aviatec, S.A. is a Panamanian company authorized to conduct business in Panama. During the year 1994, the corporation was in the process of developing plans and strategy to come to the United States to do business, and one of the steps that it was informed it had to do, was to apply to do business in the State. Due to this, the form to which this affidavit refers was completed and sent to your office at a time when the corporation's only activity was that of planning to begin business in the State of Florida within the foreseeable future. We do not know or are aware of who inserted on item 6 in pencil or ink, the number 1-6-84, which happened to have been the same one as that of the date of incorporation, but this is in error. The company has not in the past or even presently, has or had any tangible or intangible property with situs in Florida, nor has it carried on any income producing activity in this State.
