

The following is in reply to your letter of January 26, 1995, L#395A00003397.

The Whale's Tale, Inc., has never had, and does not currently have, a place of business in Florida. Our entire business activity in Florida has been limited to demonstrating our products at two to three Boat Shows each year, i.e., The Miami Boat Show, The Fort Lauderdale Boat Show. These events run 4-5 days. Our inventory is trucked to the Show and afterwards is returned to our Massachusetts warehouse. We do not feel that a "foreign corporation" authority to do business as per Statue 607.1501 was necessary.

We are contemplating moving our assembly and warehousing operations to Florida, and for that reason we filed an "Application by Foreign Corporation for Authorization to Transact Business in Florida".

At this time we do not have a place of business in Florida and use our Florida home address for correspondence purposes.
