APA, Inc. is a small business that operates as a subcontractor to prime contractors who do business with the Federal government. Court annual revenues are in the \$1.6 to \$2.0 million range, depending onto how good a year we have. While we are a small company, we have always taken pride in being a well-managed company, and thus we are chagrined at having been unaware of the requirement to obtain authorization to do business as a foreign corporation in Florida. As the first step in rectifying this situation, we are hereby filing the subject application in response to the referenced letter.

As a result of a Department of Defense contract, under which we serve as a subcontractor, we began doing business in Florida in January of 1990. All of our work is performed at McDill Air Force Base in support of the United States Central Command. The fiscal year revenues we have earned in Florida since we began operations there are as follows:
