We have received your articles of incorporation to form a Florida domestic corporation for Mark O'Brien Productions, Inc. and your check in the amount of \$131.25. However, the articles of incorporation have not been filed and are being retained in this office for the following.

As you are aware, on March 6, 1995, this office received an "Application by Foreign Corporation for Authorization to Transact Business in Florida" (copy enclosed), for Mark O'Brien Productions, Inc.
