Gentlemen:

As counsel for J.N.D. Investments Limited (the "Corporation") we have been asked to respond to the inquiry you addressed to the Corporation earlier this year concerning the applicability of Section 607.1501 Florida Statutes to the Corporation.

Having reviewed relevant statutory and case law, we have concluded that the Corporation's activities in Florida, while requiring the filing of Florida's corporate tax returns, do not require a Certificate of Authority from the Florida Department of State. As you must certainly be aware, the threshold of activities requiring corporate qualifications under Section 607.1501 is significantly higher than the threshold of activities subjecting a foreign corporation to local taxation.

We have advised the Corporation that it must obtain a Certificate of Authority from the Florida Department of State prior to transacting business in Florida, in the event the Corporation should in the future conduct activities in Florida constituting the transaction of business for purposes of Section 607.1501, Florida Statutes.
