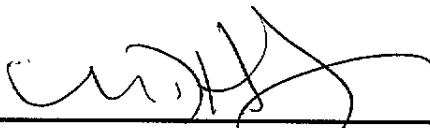

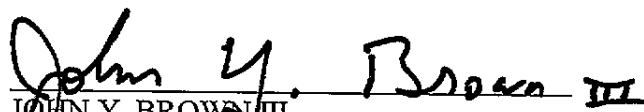
CERTIFICATE OF EXISTENCE
