To Whom It May Concern;

As the accountant for Mike Seipel's Barefoot International Training Centers, Inc. I can assure you that had my client or myself know that we needed to register with your department we would have done so. My client is an honest business person. If he had wanted to defraud the State of Florida we would have never filed for a sellers permit. We thought that we had taken all necessary steps to conduct business in your state.

I understand that some companies intentionally do not register with your state or collect and remit any sales tax. These companies should be charged a penalty, but not the companies that try to apply for all the licenses and are not that familiar with what the Florida Department of Revenue needs. We had hoped that once we registered for a sellers permit we would be noticed with other things needed.

I realize that we are somewhat to blame for coming into Florida to conduct business, but I also feel that you are somewhat to blame for not getting back to us sooner, like after we filed for a sellers permit. Penalties should be for people who knowingly violate the law, not for people who try to do all things legally. We do agree that the tax and interest are the obligation that is due from us but not the penalties.

Dear Mr. Schwab,

Please be advised that it is the responsibility of each foreign corporation to be aware of the laws which govern it. The Division of Corporations was not aware of MIKE SEIPELS INTERNATIONAL TRAINING CENTER INC.'s activities in Florida prior to 1993. The Division of Corporations received information from the Florida Department of Revenue, pursuant to section 213.053(14), Florida Statutes. That information relates to corporate taxpayers which are not on file or have a dissolved status with the Division of Corporations, and which have filed tax returns pursuant to either chapter 199 (intangible personal property taxes) or chapter 220 (corporation income tax). In July of 1993 this office received data reflecting MIKE SEIPELS BAREFOOT INTERNATIONAL TRAINING CENTER INC.'s compliance with Florida's revenue laws. On January 14, 1994, this office wrote MIKE SEIPELS BAREFOOT INTERNATIONAL TRAINING CENTER INC. inquiring as to whether it needed a certificate of authority to transact business in Florida.

This office then received the "Application by Foreign Corporation for Authorization to Transact Business in Florida", for MIKE SEIPELS INTERNATIONAL TRAINING CENTER INC., reflecting August 1, 1989 as the date first transacted business in Florida. This office had no prior knowledge that MIKE SEIPELS INTERNATIONAL TRAINING CENTER INC. was transacting business in Florida without authority until it received the application.

I regret that MIKE SEIPELS INTERNATIONAL TRAINING CENTER INC. did not properly obtain authority as required by law. Any foreign corporation that desires to become lawfully authorized to transact business in this state may contact the Division of Corporations to request the proper application, instructions and filing fees, and

receive personal assistance in the filing of such documents. The Division of Corporations also provides copies of the Florida Statutes that govern foreign and domestic corporations in Florida. Again, I emphasize that it is the responsibility of each foreign corporation to be aware of the laws which govern it and to obtain proper authority prior to conducting business when the activities of such corporation constitute the "transaction of business", as defined by s.607.1501, F.S. (copy enclosed).
