PURPOSE

To acquire, own, sell, and otherwise dispose of and deal in stocks, bonds, mortgages, securities, notes, and commercial paper of corporations and individuals (not including the discounting of bills and notes, and not including the buying and selling of bills of exchange);

To engage in any lawful act or activities for which corporations may be organized under the Illinois Business Corporation Act, relative to the foregoing;

The foregoing purposes shall be construed as independent purposes and all general or incidental powers now or hereafter conferred by law shall be construed to apply to any and all undertakings by the corporation, regardless of their nature.
