Dear Ms. Harris:

I am writing you in anticipation of resolving a problem that has certainly become a dilemma for Fujinon.

Our understanding of the Florida State Profit Corporation Annual Reporting is that it has a definite sequence of reporting, i.e., 1<sup>st</sup> Notice, 2<sup>nd</sup> Notice and 3<sup>rd</sup> Notice. The 2<sup>nd</sup> and 3<sup>rd</sup> Notices also levy rather hefty fines. We recently received your Report for 1999, however, it was earmarked as "2<sup>nd</sup> Notice" which incorporates a \$400 penalty in addition to the \$150 filing. May I call to your attention the fact that at no time did we receive the 1<sup>st</sup> Notice for 1999.

For the year 1998, we received <u>only</u> the 3<sup>rd</sup> Notice advising us of the revocation of our Company registration with your State. We were, in fact, reinstated by paying \$758.75 including penalty. May I now call to your attention the fact that at no time had we received your 1<sup>st</sup> or 2<sup>nd</sup> Notices prior to receiving the 3<sup>rd</sup> Notice.

Fujinon's reputation for prompt payment is historically well-documented. You can, I am sure, understand our frustration at the situation that has now arisen with your organization as detailed above.
