Dear Ms. Santangelo-McNatt:

This letter is in response to your letter dated January 31, 1995. We appreciate the fact that OUTDOOR ADVENTURES UNLIMITED, INC. did not willfully choose not to file for authorization before transacting business in Florida. However, any foreign corporation that intends to transact business in this state is required to obtain a certificate of authority from the Department of State prior to transacting business as stated in section 607.1501(1), Florida Statutes:

"A foreign corporation may not transact business in this state until it obtains a certificate of authority from the Department of State."

The statute directs this office to collect the appropriate civil penalty of \$500.00 for each year or part thereof that a foreign corporation transacts business in this state without authority. It is the responsibility of the corporation to be aware of and to comply with the Florida Statutes. From your letter, there does not appear to be any compelling reason for the penalty fees to be abated.
