The above-referenced client of our office has received notice from your Department concerning its registration with the Division of Corporation.

As you know, the mere fact of filing corporate income that returns with the Department does not necessarily mean the corporation is "doing business" in a manner which would require registration with the Division of Corporations. A corporate income tax return is required if the corporation has nexus for tax purposes; nexus can be based upon the ownership of realty in a state.

Section 607.1501(2)(m), Florida Statutes specifies that the bare ownership or holding of title to realty in Florida does not necessitate registration with the Division because it does not constitute "doing business."

Furthermore, Section 607.1501(2), Florida Statutes, clearly states that the listing of the activities in that section are a non-exhausting list of activities which do not constitute "transacting business" in Florida.

The enclosed affidavit of Frank M. Henry establishes that when FM Realty purchased realty it was not purchased for investment purposes. When the realty was purchased it was for intercorporate purposes. Subsequent to the purchase, the property was renovated and used by a sister corporation and payments were made to FM Realty by the sister corporation in order to pay off the mortgage

which was used to finance the renovation of the property. The lease of the property began in mid-1993.

In view of the non-exclusive nature of the listing in Section 607.1501(2), Florida Statutes, and the facts of the present situation it was reasonable of our client to not register with the Division.

However, our client, FM Realty, wishes to voluntarily register and obtain a certificate of authority in the event that the nature of its activities in Florida should change in the future. Therefore, the effective date of its registration should be 1995.

We have enclosed a completed Application by Foreign Corporation for Authority to Transact Business in Florida together with our client's check in the amount of \$70.00. Please issue the appropriate certificate as soon as practicable.


